



**DIVIDEND GROWTH SPLIT CORP.
SUSPENDS DECEMBER CLASS A DISTRIBUTION**

Toronto, December 17, 2008 – (TSX: DGS) In accordance with its prospectus and the Class A Share Provisions, the regular, non-cumulative, monthly distribution for the month of December will not be paid on the class A shares of Dividend Growth Split Corp. Under the prospectus, no cash distribution may be paid on the class A shares, if after payment of the distribution by the Fund, the net asset value per unit (consisting of one class A share and one preferred share) would be less than \$15.00. The net asset value per unit as at December 11, 2008 was \$13.31. The Fund will re-evaluate the payment of class A share distributions in each subsequent month with the expectation that normal monthly distributions will resume and a press release will be issued if the net asset value per unit is in excess of \$15.00 prior to declaration.

In accordance with the Preferred Share Provisions, regular quarterly preferred share dividends will continue to be paid.
