

BLUE RIBBON INCOME FUND RENEWS NORMAL COURSE ISSUER BID

Toronto, November 30, 2017 – (**TSX: RBN.UN**) Blue Ribbon Income Fund (the "Fund") has renewed its normal course issuer bid to purchase up to 1,854,700 units of the Fund representing approximately 10% of the public float of 18,547,985 units. The Fund may purchase up to 372,959 units in any 30 day period which is 2% of the 18,647,985 issued and outstanding units at November 23, 2017.

As of November 23, 2017, the Fund had purchased 416,900 units of the 2,221,800 units approved under its current bid at an average price of \$9.69 per unit.

The units may be purchased for cancellation from December 5, 2017 to December 4, 2018 through the facilities of the TSX or other alternative Canadian trading system and may only be purchased at a price per unit not exceeding the last net asset value per unit. The Administrator of the Fund believes that such purchases are in the best interest of the Fund and are a desirable use of its available funds.
