WHY INVEST?

- Equal weight investment in common shares of Canada's four largest publicly-listed life insurance companies ("LifeCos")
- Manager believes Lifecos are attractively valued relative to historical levels, representing a compelling entry point
- Potential for capital appreciation for Class A shares due to leveraged exposure to the LifeCos, which have a dominant market position in Canada and significant international operations
- Distributions:
 - Preferred Shares - Target of \$0.575 p.a.; \$6.57 dividends declared since inception
 - Class A Shares - Target of \$0.90 p.a.⁵; \$5.81 distributions declared since inception

Since the indices have more diversified portfolios it is not expected that the Fund's performance will mirror that of the indices. The indices are calculated without the impact of management fees, fund expenses and trading commissions, whereas the performance of the Fund is calculated after deducting such fees and expenses. Further, the performance of the Fund's Class A shares is impacted by the leverage provided by the Fund's Preferred shares.
