WHY INVEST?

- Primarily invested in common shares of Canada's "Big Six" banks
- Over the past 10 years to December 31, 2019, the Big Six Canadian Banks have outperformed the S&P/TSX Composite Index on a compound total return basis by an average of approx. 89% and have increased dividends by an average of approx. 87%³
- Canada's banks were ranked among the soundest in the world by the World Economic Forum in 2018
- Potential for capital appreciation for Class A shares due to leveraged exposure to the common shares of the Big Six Canadian banks
- Attractive distributions:

Preferred Shares - Target of \$0.50 p.a.; \$7.11 dividends declared since inception. Class A Shares - Target of \$1.20 p.a.⁴; \$16.85 distributions declared since inception.

The table shows the Fund's compound return on a Class A share, Preferred share and unit for each period indicated compared with the S&P/TSX Capped Financials Index ("Financials Index"), the S&P/TSX Composite Index ("Composite Index") and the S&P/TSX Preferred Share Index ("Preferred Index") (together the "Indices"). The Financials Index is derived from the Composite Index based on the financials sector of the Global Industry Classification Standard. The Composite Index tracks the performance, on a market weight basis, of a broad index of large-capitalization issuers listed on the Toronto Stock Exchange ("TSX"). The Preferred Share Index tracks the performance, on a market weight basis, of a broad index of preferred shares trading on the TSX that meet the criteria relating to size, liquidity and issuer rating. The Fund passively invests on an approximately equal weight basis in a portfolio comprised of six Canadian banks which are in both the Financials Index and the Composite Index but may hold up to 10% of its assets in global finacial services companies. Since the Indices have more diversified portfolios, it is not expected that the Fund's performance will mirror that of the Indices. The Index returns are calculated without the impact of management fees, fund expenses and trading commissions, whereas the performance of the Fund is calculated after deducting such fees and expenses. Further, the performance of the Fund's Class A shares is impacted by the leverage provided by the Fund's Preferred shares.
