**WHY INVEST?**

- Approximately equal-weight portfolio of at least 15 large-capitalization North American oil and gas companies
- Focus is primarily on large capitalization issuers with significant exposure to a potential rebound in oil prices
- Portfolio securities are S&P/TSX Composite Index or S&P 500 Index constituents which have a market capitalization of at least \$2 billion (portfolio average market capitalization is \$48.7 billion) and pay a dividend (portfolio weighted average dividend yield is 2.6%)<sup>5</sup>
- Potential for capital appreciation for Class A shares due to leveraged exposure to the Portfolio
- Distributions:
  - Preferred Shares - Target of \$0.50 p.a.; \$1.80 dividends declared since inception
  - Class A Shares - Target of \$1.20 p.a.<sup>4</sup>; \$3.21 distributions declared since inception

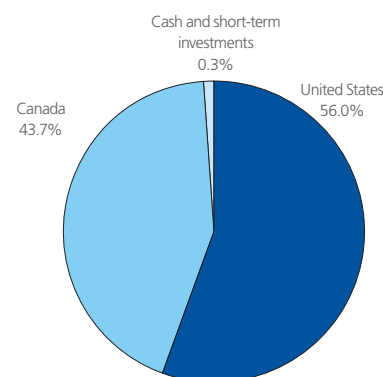
To provide holders of Preferred shares with fixed cumulative preferential quarterly cash distributions and to return the original issue price on the maturity date.

The table shows the Fund's compound return on a Class A share, Preferred share and unit for each period indicated compared with the S&P/TSX Capped Energy Index ("Energy Index") and the S&P/TSX Composite Index ("Composite Index"). The Energy Index is derived from the Composite Index and tracks the performance of equity securities that are in the energy sector of the TSX. The Composite Index tracks the performance, on a market-weight basis, of a broad index of large-capitalization issuers listed on the TSX. The Fund invests, on an approximately equal-weight basis, in a portfolio comprised of at least 15 large-capitalization North American oil and gas companies. Since the indices have more diversified portfolios that only include TSX-listed issuers, it is not expected that the Fund's performance will mirror that of the indices. The Energy Index and the Composite Index are calculated without the deduction of management fees, fund expenses and trading commissions, whereas the performance of the Fund is calculated after deducting such fees and expenses. Further, the performance of the Fund's Class A shares is impacted by the leverage provided by the Fund's Preferred shares.
