**WHY INVEST?**

- Primarily invested in common shares of Canada's "Big Six" banks
- Over the past 10 years to December 31, 2018, the Big Six Canadian Banks have outperformed the S&P/TSX Composite Index on a compound total return basis by an average of approx. 197% and have increased dividends by an average of approx. 75%<sup>4</sup>
- Canada's banks were ranked among the soundest in the world by the World Economic Forum in 2017
- Potential for capital appreciation for Class A shares due to leveraged exposure to the common shares of the Big Six Canadian banks
- Attractive distributions:  
Preferred Shares - Target of \$0.50 p.a.; \$6.49 dividends declared since inception.  
Class A Shares - Target of \$1.20 p.a.<sup>5</sup>; \$15.35 distributions declared since inception.

Since the indices have more diversified portfolios, it is not expected that the Fund's performance will mirror that of the indices. The Financials Index and Composite Index returns are calculated without the impact of management fees, fund expenses and trading commissions, whereas the performance of the Fund's Class A shares and units are calculated after deducting such fees and expenses. Further, the performance of the Fund's Class A shares is impacted by the leverage provided by the Fund's Preferred shares.
