**Why Invest?**

- Primarily invested in common shares of Canada's "Big Six" banks
- Over the past 10 years to March 31, 2022, the Big Six Canadian Banks have outperformed the S&P/TSX Composite Index on a compound total return basis by an average of approx. 96% and have increased dividends by an average of approximately 101%<sup>3</sup>
- Potential for capital appreciation for Class A shares due to leveraged exposure to the common shares of the Big Six Canadian banks
- Attractive distributions:
  - Preferred Shares - Target of \$0.50 p.a.; \$8.11 dividends declared since inception
  - Class A Shares - Target of \$1.20 p.a.<sup>4</sup>; \$19.25 distributions declared since inception
