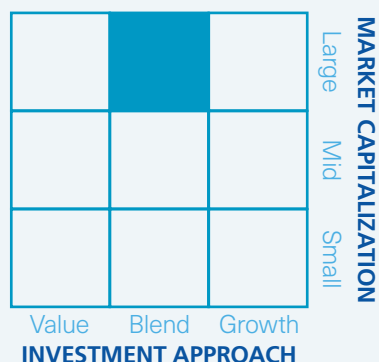

## Overview

Rigorous fundamental analysis focuses the portfolio on global Technology companies which offer a combination of growth and value characteristics.
